- d) *NAC 623A.511 Complaints against certificate holders: Review of complaint and response by designated member of the Board to determine violation has occurred; recommendation to the Board. (NRS 623A.130)*
- e) *NAC 623A.170 Schedule of Fees*
- e) *and other matters that may be pertinent to this subject.*
